Minutes of May Meeting:

Bob Moffett discussed with the club the updating of the club by-laws and they should expect to be given a copy via e-mail or USPS for their review during the September meeting.

Clarification with AAW revealed that in order to be covered under the AAW insurance, a demonstrator must be a member of AAW. Failure to adhere to this policy could result in the club being held liable for any injuries or damages. This applies to PTWA members that wish to demonstrate under our club name. Professional demonstrators must have their own insurance.

"First Friday" at Linden Street Art Works was supported by John Morris, Lan Brady, Earl Kennedy and Bob Muir as well as some of the club members that had their work displayed. This was an opportunity for us to get out and support the club through education within the community. Other opportunities are being investigated.

Bob Holtje gave the treasures report.

Wayne Peterson will be selling Anchorseal for \$11 a gallon a tremendous savings. He will bring about 20 gallons at the August meeting for purchase.

Jim Terry reported that the members picture gallery will be made available as a PDF file and possibly via the website if security issues are resolved. If you have not had your photo taken see Jim at the next meeting. This is a photo directory that will help us identify and learn to attach a name to a face between meetings.

John Morris conducted the Presidents' challenge (boxes) and the instant gallery.

Mike Stafford's demo was on turning boxes. He stated that you should use hardwood that has been kiln dried so that there is less shrinkage in the wood after the box has been turned. He uses blocks that are about 3x3x6 so that you have enough wood for two tenons. One for the lid and one for the base. The general rule of thumb is that you want the box to be $2\frac{1}{4}$ - $2\frac{3}{4}$ and $1\frac{1}{2}$ for the lid. Boxes that are larger than 4x4 are prone to humidity changes. Get the shape of the box drawn down so that you have a visual picture to shoot for.

Directions to Wall Lumber and the Mason's

Take US-220 North to SR-135 Mayodan, NC MAYODAN-EDEN EXIT

(you will see a Lowes Home Improvement on the left side of the highway)

Turn Left at the stoplight travel approximately 1-2 miles. Wall's is on the left after you cross the bridge.

When you leave Wall's go back to US-220 crossing the bridge and continuing North on US-220.

Approximately 5.6 miles take the STONEVILLE EDEN EXIT

(you will see a water tower at the top of the ramp) Do not take the 220 by-pass exit which will be the first Stoneville exit you come to. LOOK FOR THE WATER TOWER)

Turn left at the top of the exit.

Drive approximately 4 miles and turn right onto Victory Hill Church Road. (you will go around a curve with a fire department caution sign and the road is on the right. If you miss it turn around at the fire department.)

Drive approximately 3-4 miles and Bennett Road is on the right.

(look for the pretty log home on the right Bennett Road is just beyond that.)

We are at 531 Bennett Rd. Red fence and white house on the right.

If you use a GPS it will take you down Goinstown Rd to Bennett off of Hwy 770 part of which is dirt. That is normal for our neck of the woods .

NORTH CAROLINA WOODTURNING SYMPOSIUM - OCTOBER 23 - 25

This is the best regional woodturning symposium in the USA and second only to the national AAW symposium. The demonstrators include the best in the world.

- The cost is the same as for the 2007 Symposium and includes lunch on Saturday and the Banquet Saturday night. Full registration is \$185.
 - There will be 63 demonstration periods – 7 per each of the 9 rotations. So, registrants can sit through 9 entire demonstrations or move among several more. The demonstration topics include something for turners of all skill levels and interests. The demonstration schedule is on the Symposium website - <http://northcarolinawoodturning.com/>
 - All full registrants will be entered into a drawing for one of 10 tuition only Education Scholarships (8 to the John C. Campbell Folk School and 2 to the Arrowmont School of Arts and Crafts). The drawing will be during the Banquet, but you do not have to be present to win.
 - There will plenty of time for social interactions with old and new friends. The space for vendors and socializing will be larger than in 2007.
 - Watch the website for updates, especially for vendors. Although vendors have been cautious about committing due to the state of the economy, as of May 20, 2009, there are 4 committed: Craft Supplies (4 booths), John Jordan tools (2 booths), Sanding Glove, and Thompson Tools. Additional commitments are fully expected well before the Symposium date.
 - There will be a very enjoyable auction after the Banquet, which will include pieces, donated by the demonstrators and much, much more.

FROM WEST OF GREENSBORO

- Take I-40 East to Exit 212 (Bus-40 Greensboro To Bryan Blvd). Exit is from the right lane.
- At the top of the Exit 212 ramp take Exit 24 (To Bryan Blvd. PTI Airport). You will now be headed north on the new highway.
- Exit the new highway onto W. Friendly Ave. and go left (west) on W. Friendly.
- Go about ¼ mile west on W. Friendly to Chimney Rock Rd. and turn right (north at traffic light) on Chimney Rock Rd.
- As Chimney Rock Rd. parallels the new highway, you will come to the intersection of Ballinger Rd.
- Turn right on Ballinger and go under the new highway. Shortly beyond the overpass Leonard Recreation Center will be on your left.

FROM EAST OF GREENSBORO

- Take Bus-40 through Greensboro
- Take Exit 24B (To Bryan Blvd. PTI Airport). You will now be headed north on the new highway.
- Exit the new highway onto W. Friendly Ave. and go left (west) on W. Friendly.
- Go about ¼ mile west on W. Friendly to Chimney Rock Rd. and turn right (north at traffic light) on Chimney Rock Rd.
- As Chimney Rock Rd. parallels the new highway, you will come the intersection of Ballinger Rd.
- Turn right on Ballinger and go under the new highway. Shortly beyond the overpass Leonard Recreation Center will be on your left.

FROM THE NORTH SIDE OF GREENSBORO

Ballinger turns west from New Garden / Guilford College Rd. just north of Guilford College. The following link to Mapquest will detail this area. Directions from Bus-40 to Guilford College Rd have been removed since the above directions are much faster from Bus-40.
